Children's Mental Health Committee report – Teriann Parker

Crisis Center update – Randy Rodriquez

- Randy told the group that the Crisis Center review board was in the process of scoring the responses to the RFI. We will probably which community was awarded the crisis center by next week.

Optum Idaho quarterly report – Isaiah Sarault

- Isaiah shared a handout that included information such as number of providers, call answer time, and complaints resolution statistics.
- Optum has focused on three things over the last quarter: web-based training, provider information forums, and gathering outcomes data.
- Optum will be recruiting for a field quality specialist in each region who will look at quality of care.
- Optum would like feedback from regional boards to determine priorities for providing information in the future.

- There was discussion that some may be interested in forming a subcommittee for feedback.
- Requests from those present include:
 - We need regional ACT Teams
 - We need to include family engagement while in a facility
 - We need to have some CBRS contact continue while the client is in a facility
 - We need a good way to develop a relationship with schools
 - There is a desire to provide wraparound service
 - We need supportive housing to assist with recovery
