Josie Russell-Adkins updated the group on the referrals for Person Centered Planning and the Child and Adolescent Needs and Strengths (CANS) assessment. Region 7 is getting more than half of the referrals from the State. Referrals are coming from Medicaid and through group respite.

Ms. Russell-Adkins reports she has two families in the Wraparound Pilot Program. They are using information from the CANS assessment to support Wraparound.
