Liberty Healthcare is now doing the full Child and Adolescent Needs and Strengths (CANS) eligibility assessments.

Josie Russell-Adkins reported that Children's Mental Health at IDHW has additional staff trained in wrap around and they have started taking new cases.

Dave Peters offered to work with agencies to help with the process of getting providers CANS certified through the ICANS helpdesk.

Dave Peters reported on the progress of the Person Center Plans across the state. There have been 826 submitted with 337 of them from Region 7. Of the 337, 163 are complete and 120 are in progress. The average time to complete the process is 65 days.
