Agenda item: Idaho Federation of Families Presenter: Steve Graci

Steve Graci presented information to the group about Youth Move which is a national organization. The Idaho Federation of Families is the state affiliate for Youth Move National. The group's focus is bringing kids together in support of each other. Steve gave an update on projects that local Youth Move groups are doing in our area.

Steve was going to present information on the Parent Network but since Laura was there, he let her speak on the topic. The parent training has been completed and it went well.

The Paper Tigers showings are now complete. They went well, had good participation, and were well received. The follow up to Paper Tigers will be a film called Resilience. It will be shown in the Spring of 2017.

The group discussed requesting the R7BHB to donate money so the school districts in our region could purchase a copy of Paper Tigers to use for teachers and families. The schools are able to purchase copies for \$75.00 each. Contact will be made with the counties to see if they would be willing to purchase and share the video with the schools if the money was donated. Teriann will have preliminary discussion with the R7BHB today to make sure they are supportive before we approach the school districts to see if there is an interest. Dave and Kathy will make contact with the districts.

Laura Wallis presented information regarding the YES Project. She attended the training in Boise last week. YES stands for Youth Empowerment Services and is a result of the Jeff D Settlement. The YES Project will change the way SED kids

are treated in the state of Idaho. She gave the group a description of the overall concept of the program. The program will improve the quality of care for SED children throughout Idaho.

Agenda item: Respite Funds Presenter: Dave Peters

Janet gave examples of respite programs at the schools. Laura feels the kids need a group program that they want to be at as opposed to a school function for which they are not ready for. The goal would be to have a program where the kids wanted to go. Laura feels that after school doesn't really provide respite and thinks an evening program would work best because after school is when kids are seeing therapists.

Randy feels that if the respite funds are going to be accessed, it needs to be done now and separate meetings need to take place so that we can move forward and accomplish this.

Teriann and Laura will schedule a meeting to discuss respite funds. After it is scheduled, it will be announced via email to the group. All are welcome to attend.

Logan Zuck provided comments on the Youth Move program and the positive effects it could have on families. He will be working with Kathy to try and set up the program in our community.
