They received a temporary certification to further their certification process with the state. After competing about 100 hours of further training they are able to fully certify with the state. So far about 75 parents have gone through the training.

Region 4 is doing a pilot project on respite care. CBRS workers are training to be the respite providers for that area. Respite care is available in three ways for that region: group, personal contact, and CBRS workers in that area. There are about 60 days left in the pilot program.

Optum made an arrangement with the Idaho Children's Trust Fund to show a movie called Paper Tigers. It is a documentary based on kids with disabilities/mental health issues in schools. They are going to do four different programs; one will be October 13<sup>th</sup> in Idaho Falls. There will be a panel discussion afterwards. They would like Logan Zuck to be on the panel. The target population for this event is mental health professionals and teachers, but anyone is welcome to attend.

We have respite money that is supposed to go to the RBHB. The funds have never fully been used. Any family that has a diagnosis from a licensed professional can access funds for respite care. CMH is going to maintain that money and the board will get information out to families that could utilize the funds or become respite care takers.

Community Night Out is August 10<sup>th</sup>. The group could have a booth and participate in the scavenger hunt. At the Roaring Youth Jam (August 11-13) you can also have a booth, but have to provide a craft activity. It is an all-day activity for the whole 3 days.
