3. YES (Youth Empowerment Services) SYSTEM OF CARE | Josie Russell-Adkins

- Quarter 3 2018 data regarding Child and Adolescent Needs and Strengths (CANS), level of care was presented. Out of 1,300 CANS assessments, 19% were at level zero; 37% were at level 1; 15% were at a level 2; and 29% were at level 3.
- The Wraparound Coaching Pilot starts on July 1, 2019. The coaches support the care coordinators in Wraparound.
- Targeted Care Coordination training has started. Optum is providing the training through Relias.
 Target Care Coordination will now be taking referrals for Person Center Service Plans (PCSP).
 This is now a billable service through Optum.
- Person Center Plan (PCP) has officially been changed to Person Center Service Plan (PCSP).
- There is a YES screener designed to help non mental health professionals determine if they should refer a youth to mental health services. The screener is available on the YES website at https://youthempowermentservices.idaho.gov.
- Information was provided on the process regarding expired PCSP's.
