## 2. IDAHO FEDERATION OF FAMILIES | Ruth York

- IFF and Optum provided Youth Peer Support Training in Idaho Falls on July 29-30, 2019. Nineteen participants, ages 20 to 60, were trained. Training was focused on mental health.
- There is funding for Strengthening Families through Southwest District Health.
- The Graham Slam golf tournament will be held on September 8-9, 2019. Funds raised will help improve children's mental health and wellness across the State.
- Ruth provided information on a pilot after school program in the Boise area.

# 3. YES (Youth Empowerment Services) SYSTEM OF CARE | Josie Russell-Adkins/Dave Peters

- Josie reported on building Wraparound internally and within the community and shared flyers about the program. Idaho Wraparound has a new logo that will be used to standardize all publications.
- Josie provided information on the YES Newsletter. To receive the newsletter, go to their website at <u>www.yes.idaho.gov</u> and sign up.
- Dave Peters reported on the current Children's Mental Health caseloads. As of August 15, 2019, Person Centered Services Plans (PCSP) are now being done by community providers. This will allow Children's Mental Health to provide more Wraparound in the region. Dave requested input from providers regarding the PCSP with the Targeted Care Coordinators. This was followed by discussion on the process of CANS (Child and Adolescents Needs & Strengths), PCSP, and Targeted Care.

- The Parent Network is still looking for parent representation from regions 1, 2, 5, and 6.
- The 3<sup>rd</sup> Annual Parent Network Workshop will be held October 17-19, 2019 in Boise.

- Laura Wallis and Amy did an interview with Optum this week on the YES System of Care and interactions, as a parent, with the system. The video will be used for Optum providers and employees.



## 5. PARTNERSHIP FOR SUCCESS (PFS) GRANT DISCUSSION | Marco Erickson

- Marco provided an update on Strengthening Families training. Seventeen individuals were trained in our area. Community Youth in Action are putting together the first Strengthening Families class on September 11, 2019. The training is a 14-week course. Five trainers will be at the training.
- Prevention Technology Transfer Center will provide training on prevention services specifically focusing on the topic of sustainability. The training will be on September 9, 2019 in the EIPH Conference Room. There is no cost to attend.
- Marco still has conversation cards available. They are a great tool to start conversations with children and families on the topic of underage drinking.
- Marco reported on the Idaho Falls Chukars Sticker Shock campaign. There will be an alcohol-free night at the field on August 27, 2019 and will involve a youth presentation. The EIPH/PFS grant is sponsoring a Chukars game on September 4, 2019 to promote the prevention of underage drinking. The game starts at 7:15 p.m. at Melaleuca Field in Idaho Falls.
- The Office of Drug Policy featured work of the EIPH/PFS grant in their August 2019 newsletter.
