- Amber Gray reported that Respite changes are being made at Children's Supportive Services.
- Janet Goodliffe provided information on the Idaho Children's Trust Fund collaborating with Optum to add ACE (adverse childhood experiences) questions to the Behavioral Risk Factor Surveillance Survey. The Stewards of Children, Darkness to Light program, is being shared across the state. The Boise School District has committed to training all their staff. Janet will provide additional information at next month's meeting. Teriann Parker will check to see if the Darkness to Light program can be a part of the training during Children's Mental Health Awareness Week.
- Dave Peters stated that so far, 27 referrals for Person Center Planning have been made.
