## Agenda item: YES & Parent Network

#### Presenter: Dave Peters

- Dave Peters handed out a YES Program Access Model flow chart. This model is effective 1/1/2018. The Idaho Department of Health and Welfare is rolling out new services billable through Medicaid. It is being done through the 1915I process. The Legislature approved to increase the poverty level for Medicaid participants through the 1915I process from 185% to 300%. This will provide services to more children and youth through Medicaid.
- As of 1/1/2018, respite will be a billable Medicaid service.
- Liberty is the independent Child and Adolescent Needs and Strengths (CANS) assessor. Following a CANS assessment, a Person Centered Plan would be completed with input from the family.
- There was discussion on how to get information on YES to physicians throughout the region.
- The Committee agreed to meet at 9:00 a.m. instead of 10:00 a.m. for the January 19, 2018 CMH Committee meeting. Dave Peters and Josie Russell-Adkins will provide additional training on the YES Program Access Model. Those present at the meeting agreed to invite co-workers, case managers, and billing personnel to the training. Amy Minzghor offered to produce a flyer and distribute it. She will approve the flyer through Dave Peters and Brandi Daw before sending it.
- The YES Program Access Model will be a standing agenda item for future meetings so that updates and follow-up information can be shared with the group.
