Agenda item: Children's Mental Health Awareness Week – May 1 to 7 Presenter: Teriann Parker

Teriann thanked everyone for their input last month regarding proposed activities for Children's Mental Health (CMH) Awareness Week in May. Listed below are the details for the planned activities scheduled for May 4, 5, and 6, 2017.

- May 4 In the morning at the Idaho Falls ISU campus (Bennion Building), Dr. Lyons will be giving a presentation on CANS (Child and Adolescent Needs and Strengths Assessment) followed by a panel discussion on the Yes (Youth Empowerment Services) project. In the afternoon, there will be a Mental Health Stigma training with Logan Zuck along with an Ethics training by NASW (National Association of Social Workers).
- May 5 Optum will be showing Paper Tigers at the Idaho Falls ISU campus auditorium in the evening (time still
  to be determined). Optum will also show Resilience on May 17 at the Shoshone Bannock Convention Center in
  Fort Hall, ID.
- May 6 The CMH Committee has reserved the Idaho Falls Public Library to display the poster and photo contest entries. They will be displayed from 10:00 a.m. to 1:00 p.m. There will be an awards presentation at the library from 1:00 p.m. to 2:00 p.m. Also in the afternoon (exact time still to be determined), Steve Graci will give a presentation on The Idaho Federation of Families. After the activities are finished at the library, there will be a variety of bands playing music at Freeman Park in Idaho Falls to celebrate Children's Mental Health.

Since the CMH Committee identified Juvenile Justice as a needed focus for CMH activities, Dave Peters suggested that the committee makes sure to invite Juvenile Probation to all of the events recognizing CMH Awareness Week.

Teriann passed out flyers for the CMH Awareness Week poster contest. They will be distributed throughout the region. The flyer will be on the EIPH website and Mimi will email it to the R7BHB community group. The deadline for entries is April 17, 2017. Entries will be submitted to EIPH offices in each county except for Butte and Bingham as EIPH does not have offices in those counties. Alternate arrangements will be made for those two counties. When the arrangements are finalized, the entry form will be modified to reflect this information. A group from the CMH Committee will judge the entries. Art baskets will be presented to the winners.

The "Get the Ball Rolling" photo contest will encourage people from across our region to participate in Children's Mental Health Awareness Week. An informational poster will be distributed to the high schools in District 91 and District 93. Steve Graci will provide more of the balls for distribution.

Folders with educational materials will be distributed to CMH Awareness Week participants instead of bags. There may also be space available for agencies to have a table to distribute their information and promotional materials.
