    - Prevention activities:
      - Ammon Pumpkin Walk Displaying shoes representing the number of individuals who lost their life to drugs in Idaho last year
      - Trick or Treat
    - TRAPPED event happened.
      - Data collected at TRAPPED is similar for the last two (2) years.
        - Vaping, marijuana, and alcohol were the top 3 substances reported used.
          Does not seem to be a problem with prescription drug misuse.
