8. BEHAVIORAL HEALTH IN THE SCHOOLS PRESENTATION

Brett Plummer, School Board Chair, presented information about behavioral health issues within the school system. There are currently 358 children in the Challis area school system and two school counselors for all grades.

9. COMMUNITY REPORTS AND ROUNDTABLE DISCUSSION

Listed below are specific gaps and needs in the community that were identified:

- Lack of behavioral health education for families starting at the earliest age possible
- Lack of education regarding healthy relationships, coping strategies, and skills building
- Lack of appropriate school aged mental health screenings
- Lack of behavioral health services for children and adults
- Lack of behavioral health specialists in rural areas
- Inability to process IEP (Individualized Education Programs) assessments in a timely manner
- Lack of employment opportunities
- Lack of volunteer opportunities for youth
- Lack of funding for programs
- Lack of manpower
- Lack of emergency transportation to behavioral health facilities in the region
- Lack of follow up care after returning to the community from emergency visits
- Lack of Child Protective Services
- Sustainability of tele-psych
- No resource officer in the schools
- Lack of education on harm of cyberbullying
