### 1. WELCOME, INTRODUCTIONS, AND ROLL CALL

Vice Chairman Janet Goodliffe, filling in for Chairman Sam Hulse, called the meeting to order at 11:30 a.m. Roll call completed.

### 2. ADDITIONAL AGENDA ITEMS

There were no additional agenda items.

### 3. APPROVAL OF MINUTES

**Motion:** Chris Freeburne made a motion to approve the August 17, 2018 R7BHB meeting minutes with one clarification. Under the Community Reports Section, please state, "State Hospital has not yet moved their adolescent services. They will move in the summer of 2020." Seconded by Commissioner Bryon Reed. Motion passed.

### 4. FINANCIAL REPORT – AUGUST 2018

Total revenue is \$4166.00 and total expenditures are \$2,552.68. The YTD balance is \$8,332.00. With carryover dollars from previous years, the current fund balance is \$57,904.97.

### 5. GRANT REQUEST DISCUSSION

The Board discussed establishing solid funding criteria for grant requests.

**Motion:** Judge Greg Moeller made a motion requesting Mimi Taylor to put together a sample of information that could be added to the grant application which would identify the types of requests that would align with the R7BHB mission and support the strategic plan. Ms. Taylor will present the information at the next meeting for the Board's consideration. Seconded by Jason Marquette. Motion passed.

### 6. GRANT REQUEST

Community Youth in Action (CYA) submitted a grant request for support of the Teens Rising Above Peer Pressure Every Day (TRAPPED) Leadership Retreat. The request is for \$5,209.51. Becky

Leatham, Cathy Sexton, Kathryn Suci, and Willow McCracken provided information about the Leadership Retreat and answered questions regarding specific line items on the funding request.

**Motion:** Teriann Parker made a motion to approve the grant request by funding the total request amount of \$5,209.51. Seconded by Melanie Fowers.

Board members discussed concerns regarding the amount of the request.

**Motion:** Crista Henderson made a motion to amend the previous motion. Seconded by Elaine Sullivan. Motion passed.

**Motion:** Crista Henderson's made a motion to fund a total of \$2876.83: \$1175.00 for the challenge course, speaker hotel fees, town hall meeting space, and Obstacle Course; \$816.98 for speaker fees; and \$884.85 for youth & volunteer t-shirts. The amount of \$884.85 for t-shirts will come from money budgeted for the Children's Mental Health Committee in FY19. Seconded by Elaine Sullivan. Motion passed.
