### 1. WELCOME, INTRODUCTIONS, AND ROLL CALL

### 2. ADDITIONAL AGENDA ITEMS

### 3. APPROVAL OF MINUTES

### 4. MENTAL HEALTH AWARENESS MONTH

Crystal Campbell from the Idaho Department of Health and Welfare (IDHW) provided information regarding activities in May for Mental Health Awareness Month. They are requesting nominees for the Voice of Idaho award. The regional behavioral health boards should work with the community to endorse two nominations. The nominees must be an Idaho resident and be a person living with a mental illness. The awards committee will select one Voice of Idaho Award. The award will be presented in Boise at the proclamation event in May. Crystal will email Mimi a copy of the nomination form for distribution to our community group. There will be an events website setup and the nomination form and other information will be available on it. The event website will have a calendar for anyone to post behavioral health-related events. The website should be available within the next week. ## 6. CHILDREN'S MENTAL HEALTH (CMH) COMMITTEE REPORT

Teriann Parker reported on the February 17, 2017 CMH meeting. As part of the May activities for CMH Awareness Week, the committee would like to collaborate with Optum to show Paper Tigers and/or Resilience in our region and work with juvenile probation officers and offenders' families to provide information about children's mental health. The CMH Committee will also be participating in the poster contest sponsored by the Idaho Federation of Families. The committee will also partner with NASW (National Association of Social Workers) to provide an ethics training in the region.

- Geri Rackow announced that representatives from the Office of Suicide Prevention would be coming to Idaho Falls on March 7 to discuss the Zero Suicide Initiative. Once plans are finalized, information will be disseminated.
- Laura Wallis announced that the state level YES Communications Workgroup is looking for questions that need to be answered about the program and its plans moving forward. The workgroup will be compiling information and distributing it in a format that answers everyone's questions.
- Chairman Hulse announced that the The Crisis Intervention Team (CIT) for Region 7 is holding its annual training in Driggs, ID on April 3 - 7. This is a 40-hour certification training for first responders, dispatch, mental health advocates, mental health providers, or anyone else who is interested in mental health. There is no cost for the training. Crista announced the CIT awards banquet would be held the first week in August to recognize people involved in the program.
- Alisha Passey announced that BYDC (Bonneville Youth Development Council) is working on a project called "In a Different Light". Youth will share how they see our community by sharing images. A public showing of the pictures will held on April 10 from 7:00 – 9:00 p.m. at the Willard Arts Center/Colonial Theater. Contact Alisha if you need more information. - Chairman Hulse updated the group on the Stepping Up initiative. This is an Idaho Association of Counties (IAC) initiative that deals with reducing the number of people with mental illnesses being housed in jails. Statistically, individuals with mental illness spend three times longer in jail than people without mental illness. This meeting is held the third Thursday each month at noon at the Sheriff's office in Ammon. Please contact Sam Hulse with any questions. - Rebecca Perrenoud presented information about Operation Shield. Operation Shield provides rehabilitation services for victims of sex trafficking. They are seeking funding for their operations. Chairman Hulse confirmed that sex trafficking is a serious problem; however, also stated that the work Operation Shield is doing does not fall under the purview of the R7BHB.
- Darin Burrell asked about the status of finalizing the statement on the Board's position on the legalization of marijuana. The most recent statement, written in 2013-2014, was sent to Board members in December to review. The plan is to update the R7BHB's statement as soon as we receive the Office of Drug Policy's updated statement so our statements are consistent. Chairman Hulse said this topic would be added to a future agenda once the Office of Drug Policy updates their position. Mimi will follow up with the Office of Drug Policy to see where they are in the process of getting their position finalized. She will also send out again to Board members the most recent R7BHB's position statement on the topic.
