5. FINANCIAL REPORT

7. LIABILITY INSURANCE DISCUSSION

At last month's Board meeting, the Board approved \$1,000.00 for the rental cost of the Compass Academy auditorium to be used for training during the CMH Awareness Week activities. District 91 waived the fee and asked the CMH Committee to submit a rental use agreement, which included providing proof of liability insurance coverage.

Mimi Taylor received four insurance quotes and reviewed them with the Board. Following discussion, it was decided that further information is needed. Mimi Taylor will clarify the coverage included in the quotes. Teriann Parker will contact Compass Academy to inquire why we need to rent the space as we are actually participating in their event.

8. OPEN ITEMS

a. Conflict of Interest Disclosure Form

9. NOMINATIONS FOR MENTAL HEALTH AWARENESS MONTH AWARDS

- The Board has not received any nominations for review. All nominations must go through the Regional Behavioral Health Boards and are due to the State by March 31.
- Megan Slusher said she and Dr. Sanchez-Jaquez have an application they would like to submit but do not
 have it ready yet. Megan has the permission from the nominee to submit her name for consideration.
 Megan presented the Board with information on Kristin Cox, Peer Support Specialist at Pearl Health Clinic.

Motion: Janet Goodliffe made a motion to approve Kristin Cox's nomination if it is received in time to submit it to the State by the March 31, 2018 deadline. Second by Elaine Sullivan. Motion passed.

 If Mimi Taylor receives additional nominations before the deadline, they will be forwarded to the State for consideration.

10. CBD OIL - HB 577 DISCUSSION

- Darin Burrell provided information and updates on HB 577, a bill regrading Cannabidiol (CBD) Oil. The bill passed through the House and is now with the Senate. - Gay Miremont recently attended the National Coalition Against Drug Abuse meeting sponsored by Substance Abuse and Mental Health Services Administration (SAMHSA). She shared information regarding the negative effects of legalizing marijuana. It has been speculated that legalizing medical marijuana is the first step to ultimately getting it approved for recreational use. Ms. Miremont will forward information about speakers and research to Mimi Taylor for distribution.

11. CHILDREN'S MENTAL HEALTH COMMITTEE REPORT

- Teriann Parker updated the Board on the CMH Awareness Week activities planned for May 2018 in collaboration with Compass Academy.
- Teriann Parker also provided updates on YES and the Parent Network.

12. COMMUNITY REPORTS

- Janet Goodliffe talked about the school shooting in Parkland, FL. She feels the Board needs to be aware of the reality of mental health issues being associated with school violence. Janet Goodliffe also updated the Board on the STOP School Violence Act of 2018.
- Darin Burrell provided information on the Idaho Conference on Alcohol and Drug Dependency (ICADD) scheduled for May 21-24 in Boise, ID. Early bird registration fees are available through March 31 and CEUs will be available. Darin Burrell and Janet Goodliffe will coordinate a possible funding request for ICADD scholarships to present at the Board meeting on April 20. Darin Burrell will send Mimi Taylor a link to the conference agenda to distribute. The conference agenda can be found at http://attendicadd.com/.
- Mimi Taylor received an email from Carlos DeLeon, the Law Enforcement Representative for the Region 4 Behavioral Health Board. He was inquiring if the R7BHB would be interested in helping out with a booth they have secured at the ICADD conference in May. The intent of the booth is to educate conference attendees about Regional Behavioral Health Boards. Sam Hulse will contact Carlos DeLeon to get further details. This will be added to next month's agenda for further discussion.
- Mimi Taylor brought information and applications for the Board of Community Guardian and the State of Idaho Seventh District Guardianship and Conservatorship Monitoring Program (GCMP). Megan Harper is the Program Coordinator and can be reached at mharper@co.bonneville.id.us. This program was discussed at the February R7BHB meeting and these resources are related to that presentation.
- Crystal Campbell updated the Board on information the Board's leadership requested from the Behavioral Health Planning Council. There is not a representative from Region 7 on the Planning Council so if anyone is interested, they will need to send a letter of interest to the Council. Questions can be directed to Crystal Campbell at crystal.campbell@dhw.idaho.gov.
- Dr. Sanchez-Jaquez informed the Board that she is being sent to Texas with the Army Reserves. Megan Slusher will act as her proxy if she is unable to attend future meetings via conference call. She also requested information from the Board on Natural Peer Helpers. She offered her assistance with education on this program if anyone is interested. Sam Hulse feels her background would be helpful to law enforcement.
- Hailey Tyler and Sam Hulse recently traveled to Boise to observe the Crisis Intervention Team
 Coordination (CITC) group in Ada County. The group is part of a process of diverting people with mental
 illness out of the jails and into treatment. They came back with useful information to be used in our region.
- Mimi Taylor provided information on the Suicide Prevention Action Network (SPAN) golf tournament. It will be held on June 9 at Sand Creek Golf Course in Idaho Falls, ID. For more information, please contact SPAN, Eastern Idaho at spaneastid@gmail.com.
