Community Suicide Prevention, Sheila Murdock

Sheila updated the R7BHB on the activities of Community Suicide Prevention. They are not having the golf scramble again this year but will have the Memorial Walk in September. Center For Hope, Nancy Espeseth

Nancy provided updates on the Center for Hope.

- On April 24 from 10 a.m. – 2 p.m. they will partner with EIPH, the Department of Corrections, and BYDC (Bonneville Youth Development Council) to hold the Donuts for Drug Take Back at Costco in Ammon.
- Nancy provided information on the Recovery Coaches and their role at the Center. They work closely with detoxing clients at the Behavioral Health Crisis Center.
- The Center for Hops hosts 17 self-help groups each week. In February, 956 people attended these meetings in February. They also offer yoga and painting activities and hope to have some outdoor activities, as well.
- Nancy explained their re-entry program with the Department of Corrections.
- Provided an update on suicide prevention training.

Behavioral Health Crisis Center, Liz Yanez

Liz gave an update on the Crisis Center.

- The Center just celebrated their sixth year in operation. They support intervention and stabilization for clients struggling with alcohol and substance abuse and severe mental illness.
- They have seen an a 29% - 33% increase this year. In the month of February 2021, they served 250 people.
- They received a grant at the beginning of this year to work with the local hospitals to meet a gap for clients in need of stabilization service. They do direct admissions from the hospitals to the Crisis Center. Since the beginning of the year, they have had 53 referrals.

ICADD (Idaho Conference on Alcohol and Drug Dependency), Darin Burrell

Darin Burrell provided information on the upcoming ICADD virtual conference. The conference will be held May 24-25. Topic will include recovery, stigma, housing, and ACES (adverse childhood experiences). One of the keynote speakers will be Jamie Brower who will discuss secondary trauma. Partnership for Success (PFS) Grant, DaNae Schoenborn

DaNae provided an update on the PFS grant. The grant is through the Office of Drug Policy and focuses on reducing underage drinking and drug use. They are in year 4 of the 5-year grant.

- They have offered scholarships for the Idaho Prevention and Support Conference in April and scholarships for ICADD in May.
- They are currently offering Deterra Drug Activation Pouches. The pouches are free to the community and will also be provided at the Drug Take Back events in Bonneville and Fremont Counties on April 24.
- She is working with Mallory Johnson, Drug Overdose Prevention Specialist at EIPH, to provide naloxone training and Deterra Bags within our district.
- DaNae provided information on the Idaho Health and Youth Survey, through the Office of Drug Policy. The survey will be done at the beginning of the upcoming school year. The survey will help determine issues in our area. DaNae will be providing information to the schools once she receives it.




