The two grants, submitted by Law Enforcement Chaplaincy of Idaho and Flourish Point, were reviewed. Both meet the requirements of the grant which is focused on Crisis Intervention Training and resources to assist in treatment and recovery for behavioral health issues.

Cheryl O'Connell made a motion to increase the amount of the Martha Tanner Memorial Fund for FY2022 to \$2,000.00, and award \$1,000.00 to Law Enforcement Chaplaincy of Idaho and \$1,000.00 to Flourish Point. Seconded by John Tanner. Motion passed.

- Mimi provided information on the Crisis Standards of Care that was enacted across the state yesterday.


10. PUBLIC COMMENT
