3. APPROVAL OF MINUTES | Samuel Hulse

4. FINANCIAL REPORT | Randy Rodriquez

It was reported that the total FY20 year-to-date revenue is \$24,999.00 and total year-to-date expenditures are \$17,250.78. The YTD balance is \$7,748.22. With carryover dollars from previous years, the current fund balance is \$70,461.37. The total amount for grants awarded this fiscal year are \$4,043.00. 5. AWARD PRESENTATION

Samuel Hulse, Randy Rodriquez, and Jason Coombs presented Dave Pinegar with the Champion of Region 7 Award. The award is presented by the Department of Health & Welfare, Division of Behavioral Health. Dave is being recognized for his fight against opioids in our region. Dave and his wife opened Renaissance Ranch, a faith based drug and alcohol rehabilitation program, in Idaho Falls, Idaho.

6. RUSS WHEATLEY RETIREMENT AWARD

Samuel Hulse thanked Russ Wheatley for his seven years of service on the R7BHB. Russ is retiring from Region 7 Felony Probation and Parole at the end of January. This will be the last Board meetings for Russ but he will continue his behavioral health efforts with Community Suicide Prevention. Thank you for your service Russ.

7. BRICK HOUSE RECOVERY PRESENTATION

8. ICADD DISCUSSION | MINI CONFERENCE IN IDAHO FALLS

Darin Burrell provided information on ICADD (Idaho Conference on Alcohol and Drug Dependency). It will be held this year on May 19-21, 2020 in Boise, Idaho. The ICADD Board is planning a mini ICADD in Pocatello on October 9-10, 2020. A venue has not been selected yet and the cost will be around \$100.00. 9. FUNDING REQUEST | BYDC

The Bonneville Youth Development Coalition (BYDC) has requested the R7BHB fund \$4,288.89 for staff to attend the 2020 Agents of Change Summit in February. Lezhai Gulbransen provided information and answered questions regarding the request.

Commissioner Rose Beverly made a motion to fund the BYDC Grant Request. Seconded by Melanie Fowers.

Crista Henderson, proxy for Commissioner Bryon Reed, stated that Commissioner Reed recommended funding the request with the exception of the line item for \$1,000.00 for information dissemination since it is really unclear what that money would be specifically used for. Following discussion by the R7BHB, Commissioner Rose Beverly amended her motion as follows:

Commissioner Rose Beverly made a motion to amend her previous motion and to fund the BYDC request for \$3,288.89. Seconded by Crista Henderson. Ashley Billman abstained from voting. Motion passed.

10. FUNDING REQUEST | VOICE ADVOCACY

VOICE Advocacy requested the R7BHB fund \$3,500.00 to complete a 9-county information gathering and outreach project focused on suicide prevention. Andra Smith Hansen provided information and answered questions.

Adam Moon made a motion that due to time restraints and unanswered questions, the VOICE Advocacy grant request discussion be tabled until the R7BHB meeting on February 21, 2020. Seconded by Elaine Sullivan. Russ Wheatley abstained from voting. Motion passed.
