Motion: Janet Goodliffe made a motion for the R7BHB to donate \$3000.00 to TRPTA to be used for demand transportation passes for clients at the Behavioral Health Crisis Center of East Idaho. In addition, a Transportation Subcommittee will be formed to

address transportation issues for people with behavioral health issues. Seconded by Shawn LaPray. Motion passed.

6. PARTNERSHIP FOR SUCCESS (PFS) GRANT PLANNING

She also briefly reviewed the grant and discussed the Board's responsibility in the administration of the grant. Sam Hulse reported to the Board what activities the Bonneville County Sheriff's Office is conducting relative to underage drink in the county. Due to time constraints, the other presentations (Bonneville Youth Development Council, Community Youth in Action, Fremont County, and Custer County) were put on hold.

Motion: Darin Burrell made a motion to form a Prevention Subcommittee, chaired by Ashley Billman, to work on planning, implementing, and monitoring the PFS grant. Seconded by Janet Goodliffe. Motion passed.

The Board, along with the subcommittee, will be involved in the initial grant planning process and the subcommittee will report to the Board on a monthly basis on the status of the grant implementation with continual input being provided by the Board.
