#### 8. COMMUNITY REPORTS

- Andra Smith Hansen provided information on a Community Conversation presented by Building Hope Today. The topic is Childhood Sexual Abuse: Strengthening our Response. It will be held at the Bennion Student Union building, University Place, on October 24, 2019 from 7:00 p.m. – 9:00 p.m.
- Andra also provided information on suicide prevention trainings through VOICE Advocacy and Community Suicide Prevention. VOICE and the Center for Hope are working to provide QPR (Question, Persuade, Refer) suicide prevention training with a targeted population in Drug Court and recovery. Also, all Eastern Idaho Public Health employees will be receiving QPR training at the end of the month. Community Suicide Prevention will be donating the books for this training. In addition, there will be a focus to direct suicide prevention trainings to organizations and people in the rural counties of the region.
- Mimi Taylor announced a Community Q&A on the topic of suicide prevention, intervention, and postvention. This will take place on Saturday, October 26 from 1:00-3:00 p.m. in the cafeteria at the College of Eastern Idaho. At the conclusion of the Q&A, if people are interested in staying, VOICE will be offering the 60-minute QPR training.
- Darin Burrell and Kimber Tower provided information on Child Sexual Abuse Prevention –
  Stewards of Children, Darkness to Light. The training will be offered free to community

- Brenda Valle reported on the Bonneville Apartments in downtown Idaho Falls. They are currently in the process of taking applications. They have 35 available units with two units being designated for the homeless population.
- Shawn LaPray provided an update on the construction at BHC (Behavioral Health Center at EIRMC). The section providing acute adolescent beds is complete. They have increased their adolescent capacity from 17 to 35 beds. They are still working on the adult unit and anticipate those beds being completed later in the fall. The adult capacity is increasing from 28 to 37 beds.
