R7BHB MEMBER SPOTLIGHT (SUD ADVOCATE) | Stephanie Taylor-Silva Stephanie provided information on her role as a Re-entry Specialist at District 7 Probation and Parole/Idaho Department of Corrections. 5. PARTNERSHIP FOR SUCCESS (PFS) GRANT UPDATE | Mimi Taylor

Mimi provided an update on the PFS grant. This program focuses on prevention of youth marijuana and meth use and underage drinking. The work in this program is done by staff at Eastern Idaho Public Health (EIPH) and is overseen by the R7BHB. The current grant coordinator left the position earlier this year and EIPH is looking to hire an individual to replace her. More information will follow once a new coordinator is in place.

6. AWARD NOMINATIONS | Mimi Taylor

- a. Regional Career Achievement Award:
 - This award will be given to honor three professionals who are a current force in the substance use disorder field one from Southeast Idaho, one from Northern Idaho, and one from Southwestern Idaho. Dedicated and capable career professionals in the substance use disorder field in Idaho are of critical importance. They are most worthy of acknowledgment and recognition. To this end the Idaho Conference on Alcohol and Drug Dependency (ICADD) seeks nominations for individuals with five or more years of experience who are providing highly capable substance use disorder (SUD) treatment services in a professional and caring manner and who demonstrate their ongoing commitment to the profession. Nominations are being sought from all Regions in Idaho, though all treatment services need not have been provided in Idaho. Individuals may self-nominate.
 - ICADD has asked if the R7BHB would be willing to fund travel, meals, and accommodations (approximately \$1,160.00) for a winner from our region to attend ICADD in May. ICADD will cover the cost of the conference.
 - Mimi will email Board members information on how to nominate someone.
