4. LEGALIZATION OF MARIJUANA VIDEO AND DISCUSSION

The Board discussed and agreed they need to be proactive in their efforts to help stop the legalization of marijuana in Idaho. Revising the letter regarding the R7BHB’s position on the legalization of marijuana will be added to the May agenda.

Currently, there is a group in Idaho collecting signatures on a petition to get a ballot initiative for marijuana legalization. It is currently the most liberal petition for the legalization of marijuana in the nation. The soonest this bill could be put on the ballot is November 2018.

Funding for media outreach for anti-legalization of marijuana messaging is very limited. Television ads, radio spots, and other mass media outlets are very expensive. The Board will work on distributing public education on the dangers of marijuana through social media and other no-cost platforms. The group agreed that educating people on the subject is the best solution. Information on this topic can be sent to Mimi Taylor so she can distribute it via email to the R7BHB community distribution list.

Commissioner Bryon Reed has a copy of the presentation given by Elisha Figueroa from the Office of Drug Policy. He will send the presentation to Mimi and she will share it with the group.

5. BEHAVIORAL HEALTH CRISIS CENTER OF EAST IDAHO UPDATE

Commissioner Reed reports that Bonneville County is in the process of completing the Request for Proposal (RFP) for a new contract going forward. Brenda Price has left the Center and Commissioner Reed introduced the interim Behavioral Health Crisis Center director, Hailey Tyler. Ms. Tyler updated the board on the 1st Quarter Report. The
