Ashley Billman and Marco Erickson provided an update on the progress of the PFS grant and the Prevention Subcommittee.

- Strengthening the Families is providing training to teachers and parents in the community.
- Be the Parent social media campaign kicked off and will run through the end of May 2019.

- Marco introduced Stephanie Pustejovsky (from the Office of Drug Policy) and Marguerite Grabarek (from the Pacific Institute of Research and Evaluation). 8. HOUSING STUDY REPORT

Andra Smith Hansen provided an update on the housing study being conducted by VOICE Advocacy. Ms. Hansen hopes to have a final report in time for the July R7BHB meeting.

9. TRPTA (Targhee Regional Public Transportation Authority) DISCUSSION

- TRPTA has closed.
- Mimi Taylor provided information on a meeting that Mayor Casper will be having on May 21, 2019 at 6:00 p.m. at the Skyline Activity Center to discuss transportation issues in Idaho Falls. Ms. Taylor suggested that those who were interested in being part of the Transportation Subcommittee attend this meeting.
- Ms. Taylor shared with the group information from Eastern Idaho Community Action Partnership (EICAP) regarding funding for emergency transportation.
- Hailey Tyler reports the Crisis Center is out approximately \$5300.00 in unused pre-purchased tickets from TRPTA. Of that \$5300.00, \$3000.00 is from funds donated to TRPTA in January 2019 by the R7BHB for demand transportation passes for Crisis Center clients. Commissioner Reed recommended Hailey address her concerns to Commissioner Radford who is on Board of TRPTA.
- Commissioner Bryon Reed let the members know the TRPTA Board still exists. They are in the process of filling several vacant positions on the Board.

10. CMH Committee Report

Crista Henderson provided an update on the CMH Subcommittee Meeting.
