Elaine Sullivan made a motion to approve the funding request as presented. Seconded by Cheryl O'Connell. Motion Passed. Russ Wheatley and Teriann Ness-Parker abstained from voting on the funding request due to possible conflicts.

Board members requested the students who attend the conference come back to the Board and report on what they learned and how they will apply it in our communities.
