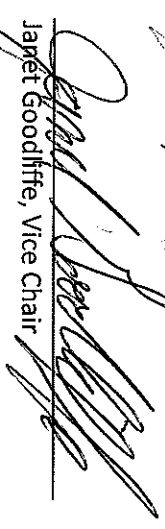
		Randy suggested that the Public Health employee, who will be working with the board, to take the lead and work with the Board to complete the application.
