8:30 AM 1. Welcome, Introductions, and Roll Call Sheriff Samuel Hulse, Chair

8:35 AM 2. **ACTION ITEM** | CMH School Safety Training Update Teriann Ness-Parker & Dustin Park

- Teriann and Dustin shared with the board about the 'Ahead of the Curve' training that they are hoping to request spending authority for. This will be a school safety training. DriftNet will be recording the training and schools/organizations can have access to that by paying a royalty fee.
- Commissioner Mendenhall asked if there is any preliminary acknowledgement from the school districts?
 - Teriann informed the board that they have multiple principals, superintendents, and higher education colleges, etc. attend the Friday weekly meetings to meet DriftNet and hear what the CMH subcommittee is doing. Had a zoom meeting with Debbie Critchfield. Just secured the Melaleuca venue yesterday morning and now need to pay for it. Have everything ready to share flyers and invite people. Dustin shared that he has met with District 91 and 93 and that they have had a good response. Dustin can do POST attendance credit for law enforcement and Teriann can do mental health CEUS, school districts can authorize PDUs.
- Plan to buy several books from the subject matter experts.

- **Official request: Dustin Park asked from the board \$10,000**, have in-kind dollars of \$25,000 from DriftNet, have asked the R6BHB for \$10,000 as well. Funds would be used for venue, video audio visual, books, lunch, rooms for DriftNet stay, agenda booklets, Spending authority for the \$8,000 that is appropriated in the Children's Mental Health subcommittee budget and \$2,000 from past funds not used.

Sheriff Hulse asked Teriann if she is comfortable using all that money, because that is the full Children's Mental Health Subcommittee budget. Teriann said yes.

- **Commissioner Brent Mendenhall made a motion that the Region 7 Behavioral Health Board approve spending authority to approve up to \$10,000: \$8,000 from current Children's Mental Health Subcommittee budget and \$2,000 from carryover for the CMH subcommittee for this event. Judge Michelle Mallard seconded. No further discussion. Motion passed.**
