### 12:45 PM 7. Behavioral Health Crisis Center Data Report

James McLain & Ken Asay

- 210 individuals at the center.
- Had 5 higher level of care to the center: 5 individuals that were not medically able to be at the center due to their health/medical.
- 17 referrals were made by the ER systems.
- 2 of the referrals were referred back to the local hospital system.
- Multiple near deaths in the community from attempted suicides.
- 1 ambulance has been called to the center for an individual who attempted suicide.

### 12:50 PM 8. Community Reports/Announcements

Sheriff Samuel Hulse

- The Mental Health Coalition of Teton Valley is going to launch an educational series in the fall. They are open to educational presenters - topics are wide open, but the community has expressed interest in: youth oriented-screen use, neurodivergence, suicide, substance use prevention. Approximately 1 hour community talks with the idea of Q&A or are there documentaries with panel discussion that can be completed?
- CIT training is April 8<sup>th</sup> 12<sup>th</sup>, rosters are full, 3 individuals from Salmon are coming down for this training, planning to do a training in Salmon, high demand for CIT training and the plan is to change to doing three trainings a year rather than two; Dustin Park shared information about CIT and CITC.

- Drug Take Back Event April 27<sup>th</sup>, 2024. Medication lock boxes and pouches available at EIPH locations.
- Division of Behavioral Health is starting a statewide newsletter with the intent of showcasing items around the state; they are going to start in May with Mental Health Awareness Month, may even do a podcast → Sean will send the information to Mallory on where to submit information.
- Dustin Park shared about the Free Hepatitis and HIV testing at D7 presented by the Community Family Clinic → Flyer will be shared in the newsletter.

- Center for Hope is doing a community conversation in Rexburg on Tuesday, March 19<sup>th</sup> from 6pm to 8pm at the Springhill Suites in Rexburg → flyer on the newsletter. The Blackfoot location is having their Grand Opening event Tuesday, March 26th with a ribbon cutting from 12pm to 1pm → flyer on the newsletter; Rexburg location is up and running, they are still working on a date.
