May Meeting Minutes

- 1. Call Meeting to Order/Welcome New Member: Amy called CRP meeting to order at 11:07 am
- 2. Call for Additional Agenda Items: Amy called for additional agenda items Holly asked that changes at DHW be put on the agenda.
- 3. Announcements/Roundtable: Caprice reported Dean Cameron has been serving as interim director. Alex Adams was appointed as director of the Department of Health and Welfare. Deputy Roxanne Printz has stepped down also.
- 4. SPaRC Center: CYA started 6 years ago- substance prevention and suicide prevention

2 years ago, the governor put out funds for assessment centers and crisis centers for adolescents. Funding lasted for two years.

This year back to a nonprofit- no sustainability built into the program.



Assessment Centers- single point of contact to connect youth with mental health needs, Centers work with youth and family to access community resources that could help the youth.

Centers partner with law enforcement, schools, and other community entities.

SPaRC can take youth for 23 hours- They have couches that pull out into beds for a one-night crisis accommodation.

SPaRC Crisis Center is different than RISE UP. If a child is having a mental health crisis they would go to RISE.

Referrals can be made at CYAIdaho.org

Foster families would refer youth to SPaRC through case managers.

The SPaRC center is not a respite care for families.

The SPaRC Center open M-Th. 10 am – 6 pm they are open, and someone is there, on Friday or weekends 24-hour call.

No clinical staff on board. They work with Grand Peaks-working with CSS, Children's Supportive Services

SPaRC does not do diagnostic assessments.

They do provide screenings.

Amy thanked them and Becky and Diana were excused
