- Welcome Salmon Area Providers
- Salmon Provider Supports, Gaps, and Needs
 - ➔ Lemhi Valley Social Services is the only behavioral health provider in this area; has a satellite office in Custer County; provide mental health and substance use treatment, case managers in the schools working directly with students, working closely with the hospital, school, and other resources; provide services for drug court; at any one time have 300+ active cases going, treat a lot of trauma, work closely with the crisis center, DD, and law enforcement
 - ➔ In the process with working with the Center for Hope on a recovery center up here
 - ➔ Support annual recovery rally coming up on September 22nd at the park
 - ➔ Would love to have supportive housing but they do not, challenge to find a place to put someone who is severely mentally ill or safe and sober housing; do have partners that will work with them at motels for a couple of days; huge shortage of housing with not a lot of availability
 - ➔ 40-50 active youth cases at any one time (Elementary school aged kids)
 - ➔ Lots of trauma → have more tools than ever before to deal with trauma
 - ➔ Trauma impact on the kids ability to learn
 - ➔ Last few years got a full time counselor in the elementary school system
 - ➔ Helo kids have opportunities to better learn about themselves
 - ➔ Only have one foster family in the whole town
 - ➔ Poverty in the community
 - ➔ New superintendent was the pioneer principal for the past few years
 - ➔ Do not have a CPS case manager in the community and they do not travel up here often → kids are not being taken from m situations unless by police -> HUGE community need to have someone check in on the families
 - ➔ Are getting a new school

- Other Community Partner Updates
 - ➔ Pearl Health ➔ Intensive Out Patient will be starting up again in January 2025, still have respite, community support, peer support, counseling, recovery coach
 - ➔ ERIMC BHC ➔ Admission age is now 12 years old at the Behavioral Health Center, Brandi can schedule a meeting and come and talk about Direct Admissions process, doctors are now on site, have child adolescent doctors as part of their behavioral health team
