- EIRMC BHC face to face (in-person) crisis assessments at EIRMC through the ER, updated
 adolescent intensive outpatient times → flyer will be sent out on February RBHB newsletter, can call
 the office and do not need a physician or clinical referral, continue to support direct admission calls
 from the community Brandi will be having 1 to 1 conversations with medical providers should they
 need help for an adolescent in crisis
