SEAP Bill #1: The funding formula is proposed to change. Current formula has not been changed in approximately 25 years. Current amount schools receive per child is 3-5% of budget. New proposal is looking to increase to 10%. This change would make funding determined per student and carry weights depending on the student needs. There are several caveats for smaller schools and weights for certain conditions. Another bill is in the wings that will bring more \$ to public schools.

SB1025 has been voted out.

HB93 has been moved along to the Governor and has the least amount of oversight, least amount of monitoring or regulation. If this bill is signed off by the Governor, the public schools are still required to meet essential services on their dollars for those children in private or homeschools. They will not receive any special funding for these instances.

HB164 is currently in the House. Current students would not qualify, any new students transferring from a public to private school would qualify for this savings account. Then they would have to continue to prove their qualifications each subsequent year.

The School Safety Training that is planned for 10/2025 is on pause because of all the changes happening in Legislature and schools. The planning contacts that we worked with last time at DriftNet are no longer there making it so connections and cost subsidizing have been lost resulting in the budget tripling. Therefore, training is on pause until things calm down and sponsorships can get figured out.

Other regional trainings would be great to focus on. Ideas mentioned:

- Ethics and Mental Health focuses would be great and enticing.
- A training for students by SROs on bullying would be beneficial how to be a friend, how to find a friend
- Understanding of electronic uses for children, education for parents about those tools and how to teach their children. Shane Boyle mentioned that they are looking to bring Jermaine Galloway (Tall Cop) and Officer Gomez to Fremont County in October 2025.
- Mental Health need of de-escalation techniques in the home. Crisis Prevention Institute (CPI) teaches de-escalation techniques for providers, parents and teachers can be billed through Magellen focusing on verbal de-escalation techniques. CPI is written into the state methods in a crisis situation.
- NAAMI is hosting a Family-to-Family group online 3/21-5/9.

Terriann will find out the cost for training a trainer with CPI and if it would be beneficial to have a representative from each organization to be trained.
