• Children's Mental Health Subcommittee
- Teriann shared about the Children's Mental Health Subcommittee Morning Meeting. Minutes from this meeting can be found on the EIPH website.
- Mikaela Butler asked if there is discussion for treatments and therapies for kids with autism in the area.
- Tina Ricks said that they identified a gap that in order to be a youth support you have to be an adult support and have to have trainings and hours.
- Rebekah Nansel with Magellan said you only need the 6 month provisional or the full year to apply to the youth peer support endorsement training and then you get your hours at provision to the youth peer support; you have to apply and meet the criteria for the youth support class

• December Meeting Cancelation
- Commissioner Brent Mendenhall motions to cancel the December 2025 meeting.

12:30 PM 6. Madison County Gaps and Needs Commissioner Eric Jackson
• Magellan changes with mental health –
- Concerns about the people that they are working with and losing jobs because funding for Peer Support services stops on December 1st
- People want to be heard and be listened to, to let their voice be heard
- There are about 600 license providers that are about to lose their jobs because of this change
- Providers Received a 4% cut
- Tueller counseling has the contract for the ACT team, that is a part of these cuts which will be a fee for service
- There was discussion about preventive care being cheaper

- Idaho Association of Community Providers have a white paper that has numbers and facts that will be released soon

- Rebekah said that she is the Provider Relations Manager, the cut came from the Department of Health and Welfare, this is in direct response from the legislature and the governor
- Talked about how can we fill the gap, we can share a flyer for the free clinic in the R7BHB newsletter
- Canvi Behavioral Health is looking into a subscription service style of healthcare to keep it affordable, that can be a planned and budgeted expense
- Rexburg Free Clinic
 - Andy talked on behalf of the Rexburg Free Clinic, talked about their services, thanked the board for the Martha and John Tanner Award Grants the past two years, shared photos of what they were able to accomplish with the past two years worth of grants
 - Talked about the book the Body Keeps the Score
- Madison County Gaps & Needs
 - The Rexburg free clinic is in their 7th year, the building they are in just got sold and as of June they are needing a new space, they were in the schools, their biggest challenge in advertising/sharing their services, state provides malpractice insurance with a health care license that comes and donates their time there, it is done by appointment, a student intern sets up the appointments
 - Discussion on lack of housing resources for individuals, especially those in recovery programming. Stewards of Recovery mentioned in Rexburg they do not have housing for their individuals and that is a big barrier; in Idaho Falls they have the Grace house, barriers to safe and sober housing for individuals. Most individuals come through referral through probation, trying to open it up to the university students,
 - Transportation needs in the community
 - Barriers with pharmacies being willing to bubble pack medications and deliver it to people homes; barrier to get people to the pharmacy
