#### 6. COVID-19 Update & Response

- Ms. Rackow reviewed the employee salary expenses accrued due to COVID-19 response since February. Funding this far has been covered by the Public Health Preparedness subgrant.
- Fluorldaho is donating approximately \$31,000 as a result of an settlement between Fluourldaho and Department of Environmental Quality (IDEQ). These funds are donated to support EIPH's COVID-19 pandemic response. EIPH will use the funds to purchase personal protective equipment for a regional cache.
- EIPH may also be receiving a \$150,000 donation from Department of Energy (DOE), again resulting from a settlement between DOE and IDEQ which is a result of a settlement between DOE and IDEQ and designated for COVID-19 response efforts. Ms. Rackow asked the board members if they had suggestions for the use of these funds, please e-mail her. This will be an agenda item for the next board meeting.
- Each health district has also received approximately \$360,000 from the Department of Health & Welfare to help with the costs of the COVID-19 response.
- Mr. Corbett provided information on the modeling process being done in collaboration with INL/Argonne National Laboratory. The timeline is about three weeks from now and the information will help us to have data on which to base future decisions for our COVID-19 response. Board members were instructed to contact Mr. Corbett if they have ideas or questions.
- At 11:00 a.m. the Board watched Governor Little's Press Conference regarding guidelines for Opening Up Idaho. Following the press conference, the Board had discussion regarding the effects and possible challenges it may create in their counties. The Board of Health members were in agreement that they would like the reopening turned over to local control at some point due to the different needs of the counties/health districts across the state.
- Ms. Rackow and EIPH staff will continue to work on educating businesses and the public on COVID-19 related issues. We are working on guidance documents that can be shared. Ms. Rackow also review new information that is located on the EIPH website.
- EIPH Staff will continue to provide information and answer questions for businesses through weekly webinars.
